Old Business

Filtration – Clarence Melancon

MEETING MINUTES

Chairman Zibrida reported the Water Treating Panel Discussion was well attended with 65 audience members in the room. With audience questions, it ran 20 minutes past its scheduled time with no attrition in audience numbers. The Symposium presented 11 papers. There were approx. 50 people at the various WT meetings. The summer meeting is scheduled to begin July 11th in Albuquerque, NM.

Task Group Reports

Oxidizing Biocide – Jon Cohen

The TG finished work on the document and it is now ready for Ad-Hoc. The TG Chairman will forward it to the Water Treatment Chairman for Ad-Hoc distribution.

White Rust – Tom Bugler

WTG 142 is near complete following a two hour TG meeting. The “cleaned up” paper will be emailed to TG members for final comments/corrections and should be ready for Ad-Hoc by the summer meeting.

Deposit Monitoring – Jasbir Gill

The TG has been reconstituted under new chair Gill. Following the meeting yesterday, the members have agreed to move forward starting with the current somewhat disorganized draft.

Green Chemistry – Mike Gilpin

The TG met and organized their work forward under the new TG Chairman.

Filtration – Clarence Melancon

The document was completed with Ad-Hoc comments addressed. The final version was provided to the WT Chairman for transmittal to the BoD.

Non-Chemical Water Treatment Devices – Bob Cunningham

The TG is attempting to narrow the scope to only those devices directly involved in corrosion/microbiological fouling/scaling and fouling of cooling water systems (excluding filters). They will attempt to agree on an agenda prior to the summer meeting.

Instrumentation and Control – Mike Dorsey

Scope development is underway and Phil Kiser has been appointed TG Vice Chairman, as The Chairman may have limited attendance due to corporate travel restrictions. They plan at least one teleconference between now and the summer meeting to agree on the agenda and make writing assignments. WT Vice Chairman will email the last TG member list he has to Mr. Kiser.

Microbiological Monitoring – Jana Rajan

A starting draft is available. The TG identified numerous deficiencies in formatting which makes it difficult to interpret. It will be reworked by the summer meeting.

New Business

Of the ideas put forth for a Panel Discussion next year, it seems to be the consensus that water reuse may work well for San Antonio. SAWS has published at CTI on their water reuse efforts in past years. A final decision on Panel Discussion topics will be made at the summer meeting.

The idea of a statistical summary of water treating experience was brought forth again. No one in the room who may have the data to produce such a summary volunteered to share it.

Mr. Zibrida announced that his term as Chairman was ending. Mr. Wangerin (former co-Chairman) will assume the position of Chairman. Mr. Kanuth will function as Vice Chairman. Additional positions will be filled by the new Chairman.
